AMENDMENT TO CONDOMINIUM BY-LAWS

Exhibit C to the Declaration of Condominium, entitled "By-Laws", is amended as follows:

BE IT RESOLVED:

That Article IV, "Members Meetings", Section 1, (page 2) be amended to read as follows:

"The annual meeting of the members shall be held at such time as designated by the Board of Administrators on the first Wednesday in March of each year at the principal office of the corporation or at such other place as may be set forth in the Notice of said meeting in Pompano Beach, Florida. At such meeting the members shall elect directors to serve until the next annual meeting of the members, or until their successors shall be duly elected and qualified, and for such other business as may be authorized to be transacted by the members."

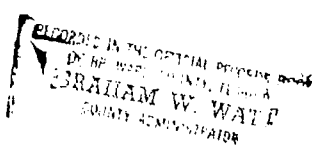
